Zoning Board of Appeals - 8/26/19 Meeting Minutes

I. Call to Order:

Chairman Broughton, noting a quorum was present, called the meeting to order at 7PM.

II. Attendance Roll Call:

All members were present and on time except for alternate Carrie Andolina who was absent.

III. Approval of Previous Meeting Minutes:

Approve Minutes of Zoning Board of Appeals Meeting held June 28, 2018. A motion to approve the minutes as presented was made by Chairman Broughton and seconded by Paul Cesana. Verbal vote - all were in favor, none opposed, motion carried 5-0.

IV. Reading of Open Hearing Public Notice:

The Open Hearing Public Notice was read by Secretary Carol Broughton.

V. Motion to Open Public Hearing:

A motion to open the Public Hearing was made by Joe Gardyjan and seconded by Paul Cesana. Verbal vote - all were in favor, none opposed, motion carried 5-0. The public hearing was opened.
